# BOARD CHAIR



DEAN BARRANT Greetings Brothers and Sisters

It is by the grace and power of our God that we find ourselves reflecting on yet another past year that we have been able to keep our doors open and furthermore to even be blessed to continue to see good fruit manifested among us, the best example being 41 baptisms in 2023. We remain completely dependent and grateful to our Lord and Savior Jesus Christ who made the declaration that the "... gates of hell will not prevail... against His Church. We take great encouragement also from Revelation 4 and 5 that in spite of seeming chaos in the world, God remains on the throne. Further, as Snr Pastor Justin led us in the study of Esther about 2 years ago, God's will and plan for His people and the advancement of His Kingdom supersedes even the very well laid out plans of those who are adversarial and are at the height of power in the kingdoms of man influenced by spiritual wickedness in high places. Therefore, having been redeemed by Blood of the Lamb, "... let us run with endurance the race that is set before us, looking unto Jesus, the author and finisher of our faith...

If ever you question the need for Morningstar to be used as an instrument by God for a time like this where peace of mind seem to be so hard to find, consider the following stats from Centre for Addiction and Mental Health (CAMH) & Ontario Shores Centre of Mental Health Sciences:

- 39% of Ontario high-school students indicate a moderate-to-serious level of psychological distress (symptoms of anxiety and depression).
- About 4,000 Canadians per year die by suicide an average of almost 11 suicides a day. It affects people of all ages and backgrounds.
- More than half of suicides involve people aged 45 or older.
- In 2018, suicide was the leading cause of death for children aged 10 to 14.
- After accidents, suicide is the second leading cause of death for people aged 15 to 24.
- Suicide accounts for 24% of all deaths among 15 to 24 year olds and 16% among 25 to 44 year olds.
- The mortality rate due to suicide among men is four times the rate among women Individuals between 15 and 44 years of age account for 73% of hospital admissions for attempted suicide.
- Women are hospitalized in general hospitals for attempted suicide at one and a half times the rate of men

Brothers and sisters, the stakes could not be higher. We have work to do and God has chosen us, among other precious congregations in our region, for this generation for such a time as this. Of course we know that our works is not what saves us as it is by grace through faith in Christ alone, but we are still called to good works. Remember we are left here as salt and light to point the world to Jesus, the Gift of God for the deliverance that is summed up in Isaiah 9:1-7.

The Board of Elders would like to thank our Ministry Team and Church office staff who are on our front lines and often-times the first point of contact for those in our community and others in our membership. Our sincere appreciation at the same level is also extended to lay persons in our membership who serve in voluntary capacities, some also on the front lines, like in evangelism, and first point of contact like, greeters. Of course there are a myriad of others of you who serve in capacities that are visible and some are not. Beyond our thanks, here is encouragement from the Word of God; "Whatever you do, work heartily, as for the Lord and not for men, knowing that from the Lord you will receive the inheritance as your reward. You are serving the Lord Christ Colossians 3:23-24.

So to our members who are not yet actively supporting any of our various ministries, I challenge you to prayerfully read 1 Corinthians 12. There you will find that God has strategically placed you here for a time like this and the Holy Spirit has equipped you with gifting that He desires to be used here. So please contact Ministry leaders in this regard.

Sincere thanks for my fellow lay elders and our families for the support. Let us seek to pray more and be rooted in the frame of mind where we are unashamedly and completely dependent on our God for His direction and His enabling of our total obedience to His leading.


#### WORSHIP SERVICES


Christmas Eve once again was my favourite service of the year. It was a joy to celebrate Christmas with the expanded worship team an the entire congregation both online and in person.

#### SUNDAY MORNINGS

The Gospel Project continues to serve as the backbone of our Sunday mornings, as we work through the Bible chronologically, showing how all Scripture points us to Jesus. This method allows children to see how the Bible fits together to tell one big story: God's plan to rescue and redeem sinners through faith in Jesus Christ. The Sunday School lessons are further reinforced through weekly emails to parents, encouraging them to continue the conversation at home with discussion questions and family activities.

During the summer, we paused The Gospel Project to work through 12 weeks of the Fruit of the Spirit; children (and their teachers) were challenged to see how following Christ would bear fruit in ways that could be seen by their friends and family. Each Sunday, our nursery team welcomes babies and toddlers to play, explore, read, and sing together in a warm, welcoming environment. The team's loving dedication to providing exceptional care during each service blesses both the children in their charge and their families.

#### VOLUNTEER TRAINING AND APPRECIATION

Our team of dedicated volunteers makes Sunday School, special events, and Kids Camp possible; their commitment to faithful service is a testament to their love of God. #### **FUSION YOUTH**


Fusion is Morningstar's Youth Group for students in grades 7-12, which meets every Friday during the school year from 7:00-10:00. Each night is filled with a bustle of activity; a place where our kids are safe to be kids, and safe to grow into maturity too. We play games, lead our young people in worship, study the scriptures, and go deeper in small groups. With a

strong group of volunteers, we've been supporting the families of our church and community in discipling our youth through the challenges of our world and of growing up.

This past year we had the opportunity to attend Snow Camp at the Ontario Camp of the Deaf with several other churches. We've been celebrating the memories that were made, strengthened relationships because of that time, and the deepened investment the youth have in our ministry. An amazing fruit following Snow Camp has been many of the youth stepping up to be a part of leading worship on Friday nights, working together to pick songs, plan, and practice. We have been consistent in teaching the Word of God, striving to meet the diverse needs across the six-year span our ministry covers, the varying abilities we welcome, and the many backgrounds people join us from. We studied God's universal reign in the book of Daniel, how to honour him with our technology and social media, how to effectively understand and share the Gospel, and an Apologetics series with several topics to equip our youth to defend their faith.

In many ways "Youth Pastor" is the most daunting role I could find myself in, yet is also a dream job – I get be an integral part of the next generation's growth in faith and maturity, while having fun along the way. I get to know them, create memories for them, play alongside them, and to advocate on behalf of them. We have seen so much growth over the years, but our kids need their church family. They need your urgent prayers. They need your attention, your heart, your time. If you pray for God's Kingdom to come, or desire to be a part of what God is doing, Youth Ministry is where you get to see glimpses of it all: it is evangelism, discipleship, worship, social work, community building, and sacrificial service.

#### YOUNG ADULTS

I would welcome you to the Young Adults of Morningstar, but its likely that they have already welcomed you. The Young Adults are an active and vibrant part of our Church body, and they comprise a significant amount of our volunteers across different ministries. Community is highly valued in our group, as most spend extra time at church to fellowship and prioritize opportunities to gather beyond their other life or ministry commitments. Our group formally meets on Sunday evenings from 6:00-9:00 pm, but you could expect to see young adults together any day of the week. We studied the book of Daniel in depth together, and explored the topic of Maturity as many continue to navigate the challenges of adulthood in our world today. I know anyone who comes to the church or our meetings will be welcomed well – and if they're open and willing, they will get connected and grow in the grace our group works hard to cultivate. We had a record number of Young Adults attend the Retreat in November, requiring a waiting list not long after registration began. In partnership with the outreach interns, the Young Adults developed a Volleyball

Outreach ministry that has drawn in many who were not otherwise connected and has also given some accessible teaching opportunities to those wanting to grow their gift of understanding and communicating God's word.

The Young Adults delight to be a part of the broader church as well, make no mistake. Invite them out, sit down with someone and share your stories, hear their questions, pray for their needs. They love any opportunity to connect, and you'll find yourself just as blessed. Pray that God would continue to give growth to this group, both in its reach and in the depth for those involved, and pray also for strong and healthy habits to be built as the pressures of life become more and more real in this stage of their lives.


#### **ABILITIES MINISTRY**

We provided training to a new member of staff at another church in a Christ-centered AODA (Accessibility for Ontarians with Disabilities Act).




our counselling takes place on the premises of Morningstar in the two counselling offices allocated for such purposes. The second location was added in 2023 with a brand-new makeover. We thank the Lord for providing donations for this room and volunteers who made this possible. From time to time, we also meet with clients in informal settings such as coffee shops or over a meal.

In 2023, both Lillian and I met with several individuals, couples and families who found themselves in need because of a life crisis or simply in need of biblical counselling for a new stage in life. I (Dennis) met with 10 couples, 13 individuals, and 3 families. Some of these were for one to two sessions, some lasting up to several months. Our starting point after carefully and empathically listening is to turn to the word of God, from which the answers invariably come.

Lillian had approximately 17 counselees this year, with an average of seven, one-hour sessions. This brings the total to 119 counseling hours. Nine of these counselees were outside of our church family either through referrals or walk-ins.

May God continue to use and further equip Morningstar as we seek to address life issues and stages from the Scriptures to give hope and answers and encourage spiritual growth and maturity.

In 2023, 14 families contacted our office and requested to be part of our monthly baby blessing or dedication services. We are always happy to oblige these families as this is part of our DNA, the spiritual care and nurture of families. Indeed, 95% of all the inquiries for our Baby Blessing services are from families loosely, or not connected with our church.

While not all families eventually start coming to our church some do, but all hear the gospel in hopes the Holy Spirit brings conviction and transformation.


#### MARTHA'S KITCHEN




#### CHRISTIAN HOMESTAY

At the beginning of 2023, we and our community partner Luke Ngo (MPL Student Services) had 3 Christian Homestay host families, and were praying and ready to try a beta-test year with a few international students. God heard our prayers and had other plans however.

In an exploratory communication to the TDSB, they offered us potentially hundreds of international students for the summer and fall. We were flattered, but could not accommodate anywhere near that number, so we told them our plan was to only recruit openly Christian families as hosts. That was our polite way of saying, "No, we can't do it."

To our surprise, they said OK! We then tried to say no again, by truthfully telling them that we wanted to provide rich experiences to our students, and would organize activities at church for them. We thought that would cause them to back away. Instead, they asked if they could provide funding for snacks!

At this time, we had to acknowledge that God had heard our prayers and was working, and we could not say no to Him. It was with great fear and trembling that we accepted, trusting that, if God is leading, He will also provide.We were terrified, and spent many sleepless nights in prayer. God was faithful through, and always provided... though usually at the 11th hour, and in ways we did not expect. In the Fall of 2023, we welcomed our first intake of 42 Colombian student experiences and response were strongly positive, and the TDSB have now asked us to again expand our operations in the new year. Maria, a part-time staff, provides care and support for the Spanish speaking moms, dads, and children at the Scarborough office on Monday and Wednesday evenings.


We want to say thank you to Cecily, the newest member of our team, for the many hours she gave serving in this ministry.

# ONLINE MINISTRY THE LIVING WORD







"I was in the hospital and came upon the Living Word and the message from the book of Ruth that evening made such a difference that I knew I wanted to be part of Morningstar..." Those are just some of the comments we received this year from some of the 70 regular viewers.

In addition to going through the Book of Ruth, we also did a series on the Attributes of God, and Paul's letters to the Ephesians and the Galatians.

In 2023, The Living Word had 3600 views, averaging 70 views weekly, with more than 70% of those views on our YouTube channel followed by our Facebook page and the remaining views on our website. We had our highest weekly views (103) in June during our series in the book of Ruth. Several of our viewers commented on how much they enjoyed and were blessed by this series. Canada is not the only country where we have a viewership. The Living Word has a global reach including the United States, the Caribbean, and the United Kingdom. Thirty-five percent of our audience watch the scheduled broadcast on Saturday, while 65% watch it at another time during the week.

My sincere thanks to you our faithful viewers and our production team Owen and Janice (who left us at the end of this year to pursue another path that God was leading her into) who gave so much of their time and expertise to produce and edit the videos and to the members of Morningstar who graciously allowed me to serve in this way. Replacing Janice was Anton who is the newest member of the Morningstar staff and responsible for helping us with all of our communication including producing and airing The Living Word.

# **GLOBAL MINISTRY**



2023 was a year of celebrating at Morningstar what God is doing around the world with Global Missions. From the monthly highlights of our missionaries to the successful Missions Conference in the fall, to the final chapter of our five-year Leaders Formation Training project in Dominica. We have been reminded that God is at work not only in our church but around the world. The reports that follow is a reflection of this ongoing work and the heart of Jesus for the lost in our world.

#### LEADERS FORMATION DOMINICA REPORT

2023 marked the official end of our Leaders Formation (LF) training program in Dominica after five years. The training began as normal in February led by Hannibal Muthar and myself as the Canadian Facilitators.

However, most of the actual leading of the sessions were intentionally given to the cohort members with us assisting. Those who lead were chosen by the planning team in Dominica. The training from series 3, book 3 focused on how church leaders are to help plant, shape and stabilize the churches under their care. Paul's letters to the Thessalonians were the basis for the study and was both helpful and challenging for the cohort to think through their role as Pastors and church leaders. We have seen growth in both the understanding of the passages and how to facilitate leading the sessions. One of the members of the cohort, who has shown a great zeal to learn is now teaching the adult Sunday school in his church because of the training he has received. His story of God's transforming work in his life is truly a work of grace and power.

The second round of training took place in July, led by Leo Paul from Fort Saskatchewan Baptist and his "Timothy" Bruce. Leo reported that they made several adjustments to help improve the overall training: "Re-phrasing questions so that they fit more appropriately to the local situation and avoid repetition – making them more focused and more practical. Occasionally limiting a response to 5 words or less, in order to get a broader range of thought, or to establish consensus. Understanding opinions how they are formed (or should be formed) and their role and use in discussions. The cohort responded well to these adjustments and incorporated them quickly. They were eager to learn, often asking specifically for an evaluation on how they had performed on their assignments."

The third and final round of training for the project, "Living in God's Household" (series 3, book 5) took place in December. Mark Hunt from Living Hope and myself were the Canadian Facilitators. Again, the bulk of the training was led by members of the Dominican cohort. This is part of the goal of helping to develop the nationals so they can continue to teach the material in their churches and elsewhere. The ongoing challenge after 5 years of training will be for the 22 trained natioal leaders to continue this process of training the next generation of leaders in their churches and assist in other parts of the region where possible.

We are very excited about the planned graduation that is slated to take place in February 2024. It will be an opportunity for the cohort and their families to celebrate their achievements. It will also be an opportunity for Leaders Formation to reflect on the work that God has done on the island of Dominica. I am fully convinced that the time, resources, and funds spent in Dominica (which in February at the graduation will be a total of ten years), has all been worth it. It has been an investment in the kingdom that will earn eternal rewards. Many thanks to Morningstar for the critical role you have played in this project. To God be the glory for all the great things he has done in those years and will continue to do in the years ahead.

# **MISSIONS CONFERENCE**



This has been an exciting and busy year for the Global Missions Team (GMT). We embarked on two significant projects to support Morningstar Christian Fellowship's (MCF) vision in 2023 of being the salt and light of the world.

#### SHORT-TERM SUMMER MISSIONS (AUGUST 23-28, 2023)

What normally took at least six months to plan and prepare for, the GMT decided to do a summer missions' trip in late May or barely three months before the end of summer. We desperately needed help... or a miracle! But God, who is rich in mercy and gracious in all His ways – never fails to amaze us. In a matter of two months and after much prayer and two failed searches, the Lord led us to Carrefour de St.-Henri, a Free Methodist church in Montreal, QC.

We praise God for using Operation Mobilization (OM) through Pastor Joshua Bautista to help us plan this trip. We are also grateful for the twelve MCF volunteers and Sahil Mahajan (from OM) who formed our multi-generational and multi-cultural team. We were reminded that our focus for the mission trip was: 1) to serve the church; 2) to serve the community and 3) to glorify God. We will also share the gospel whenever there is an opportunity. Given our limited time and resources (only 2 were bilingual speakers), the team travelled to Montreal, with God's blessings.

The church building was amid a commercial district surrounded by restaurants, bars, and retail stores. John 10:10a says "The thief comes only to steal and kill and destroy..." and was the enemy actively working at that time! Upon arrival, we already faced challenges with the language, accommodations, and a hardened community. Three of our cars were slapped with hefty parking tickets while the 4th car got stolen the next day. Moreover, after an active promotion of our Agape barbecue in the community, our spirits were dampened by the rain, so we had to reschedule the event the next day.

But Genesis 50:10 says, "what the enemy meant for evil, God meant it for our good." Undaunted by our circumstances, we persevered in prayer and the Lord strengthened our faith and renewed our spirits. Our team experienced joy while serving others and in encouraging one another. We helped promote the church's presence in the community by conducting neighborhood surveys on how the church can meet their needs: by handing out tokens of appreciation and gospel tracts to nearby businesses; and by cleaning their surroundings and interacting with and praying for the people we met. We distributed food to the homeless and held activities for children and young people at the park. Some members also had the opportunity to share the gospel. As we reached out to the community, people asked us "Why are you doing this?" Our response was simple: "because we love Jesus".

We also served the church by scrubbing its walls, cleaning its auditorium, washrooms and Sunday school rooms, emptying and disposing more than 500 expired canned goods, and leading worship service (in French) and teaching kids on Sunday.

Despite the physical limitations, language barrier, and the fiery darts of the enemy, God was in control and victorious! 2 Corinthians 12:9 says, "My grace is sufficient for you, for My power is perfected in weakness." Yes, we needed help – but we realized that JESUS CHRIST was and is all that we needed !and will ever need!









#### MISSIONS CONFERENCE (OCTOBER 21-22, 2023):


The groundwork to prepare for the Missions Conference started late last vear and continued into 2023. In order to raise the church members' awareness and encourage them to support Global Missions and the upcoming conference, we continued the presentation of our missionaries' video reports during our morning worship services. We rallied prayer partners for the conference and displayed our Missionaries' prayer requests at the monitor in the church foyer where the missionary wall, featuring their short bios (and their mission fields can also be found).

After 15 years, we again held a Missions Conference at Morningstar Christian Fellowship on Oct 21 and 22, 2023. With the theme "Whom shall I send? Who will go for us?" (Isaiah 6:8), the church congregation had the opportunity to personally meet ten of our missionaries/mission organization representatives and to hear about the "The Need" from Dave Hunt of Partners International about "Glorifying God in Global Missions" from Joshua Bautista of Operation Mobilization; and about "Discovery Bible Studies" from Ben Porter of FEB.

There were breakout sessions on Short Term Missions, the Persecuted Churches, and the Spiritual Warfare and viewed the video reports of our missionaries in France, Nigeria, Spain and Quebec.

Our panel of missionaries answered questions about their calling, and we had the opportunity to break into small groups for a dedicated time of prayer for global missions.

The gym was bustling with excitement as people visited the missionaries' display tables and learned more about their work and tapped into their resources.



Approximately 120 bagged lunches were prepared for all conference attendees and capped the first day of the conference with an appreciation dinner for our missionaries, pastors, church staff and their families.

Our conference culminated on Sunday with a twist. Pastor Dan Porter spoke about "Discovery Bible Studies", and with the help of Johnson Hsu, they divided the congregation into small discussion groups to apply the teaching during our two worship services.

The Children's Ministry also had their own special missions conference as they witnessed the gospel presented by Puppeteers from "No Strings Attached" of Calvary Baptist Church in Guelph.

By God's grace, our missionaries left the conference edified and encouraged, while our congregation was stirred up to God's redemptive work across the globe. The GMT is beyond grateful to God for His wisdom, enablement and provisions. Without Him, this conference would not have been possible, and we give HIM all the glory and praise for the great things that He has done! To our wonderful volunteers who helped with the missionary wall, food preparation and donation, logistics, set-up and tear-down, tech support, and registration; to the ministry team, church staff and the worship team; to our faithful prayer partners; and, to all who attended the conference and encouraged our missionaries – THANK YOU!

# ANNUAL GENERAL MEETING

Morningstar Christian Fellowship Annual General Meeting – March 19th, 2023

#### Dean opens the AGM

#### Opening prayer – Wisdom Marks

- Quorum was reached.
- Dean thanked the people who wore masks before, and who did not to accommodate each other.
- Dean thanked the church staff and volunteers for their service to God.
- Dean thanked the people who wore masks before and who did not as well.
- Dean thanked the old board for their service and prayers.
- Dean thanked the new board and asked church to pray for them and their service ahead.

#### Confirmation of the minutes – March 26, 2022

- Motion moved by Richard Gravesande
- Seconded by Julius Naredo
- No discussions and none against. Motion carried.

#### Motion 2 – Financials

Tapscott update – Morningstar has taken change of Tapscott now. We have decided to not renew the lease for Tapscott and advised sublessee Grace Gospel as well to make other arrangements. In Sep 2022 we wrote to the landlord to terminate the lease, and this required a 6-month notice.

- Tapscott's new landlord increased the rent significantly and the decision was made due to this.
- Based on the clause on the agreement, we had to renovate the Tapscott site and make fixes which would have cost us around 100k. We then reached out to the landlord and negotiated a lump sum to walk away after paying just 50k to the landlord.

Manny spoke about the financial statement from Dec 2022.

- Manny thanked the volunteers and financial staff.
- Due to Covid giving went down in 2020 and 2021. Now in 2022, the giving has flattened, and inflation is the factor.
- Auditors' premium remained same from the past years.
- Balance sheet we have 3 million 746 thousand in assets.
- Cash there is a significant decline in our cash kept in Duca.
  - Reasons for decline Released funds to Ajax lighthouse 86k plus. We completed our commitment to refugee family (36k). 105k was on capital expenditure.
- Statement of change in balances Board designated funds started with 231k, but it is now down to 166k.
  - Reasons for the drop 56k reduction in BDF due to capital expenditure. Expense of \$9,750 was the bonus provided to the staff. There was no budget for the bonus, but the board decided to honour our staff from the BDF.

- Revenues Have decreased from 1 mil 354k to 1mil 313k. The big reason for the decrease is that 2021 included the government assistance of 54k. Also, the giving has decreased but it is still a decent number.
- Expenses We had a decrease in expenses because benefits decreased from 9k to 7k. Reason we have less staff now. All other expenses are comparable.
- Manny handed over to Dean.

Questions on financial statement -

**Peter Mascarenhas** – Enquiry was made to ensure the amount was budgeted for salary and budget had not exceeded.

- A. Dean Dean responded that it was not, and the Board was aware that the congregation would have to approve that. In Nov and Dec, the giving in the church normally increases significantly. However, this past year the giving was very disappointing and much lower in Nov, but it picked up in Dec. So, we as the board elected by Morningstar decided to bless the staff with a bonus from board designated funds, as this was not previously budgeted under salaries and bonus.
- A. Manny For 2023, the bonus has been added to budget as discretionary, under salary and Bonus. For 2022, bonus was not budgeted, so we had to go to the BDF.

**Janet Roblin** – are we obligated to pay the government back the assistance we have received from the government?

- A. Dean we had an unprecedented pandemic that no one had experienced before. So, the government decided based on the anticipated downtrend, to offer financial support to employers.
   MCF board at that time applied for support and were approved.
- A. Manny We applied for the right benefit that applies to us. I don't see the government coming back for a refund for the grant that is given.

**Saitha Rezel** – My question pertains to the same thing, when you receive a grant from Government, are you obligated to adhere to them and forfeit your liberties?

A. Dean – A few years ago we used to get summer grants from the government to employ people from the community. So, we did that for young people, and it was great. One particular year that grant came with conditions and we decided to not take that grant as some conditions were contrary to our beliefs. Volunteers came out and supported us in that time. This is different and there were no conditions that affected our statement of faith.

#### Motion 3 to accept the financial statement 2022 as presented -

- Motion moved by Neville Issacs.
- Seconded by Peter Mascarenhas.
- Voting 2 people against the motion.
- Motion carried.

Morningstar budget for 2023

• Manny – the budget has been voted and approved by the ministry team.

- Giving dropped in 2022 by avg \$500 weekly but still good \$23,500. We are expecting the giving to go up in 2023 by 2.4%
- The salaries show an increase the main reason is for new interns. Before we had a volunteer custodian. Now we are paying.
- Property heat and lighting and maintenance charges have gone up as well.
- The budget in general has increased due to inflation and higher prices.
- Outreach budget has a big increase Reason: We have increased the mission budget and focus. Included in it is the budget for outreach pastor Johnson Hsu, budget for Alpha and bridgebuilders.

Questions on the budget for 2023 -

**Zephyr Bennett** – I saw that big dip in giving from 2021 to 2022. Can we consider bringing the passing of the offering tray back in addition to the online giving?

- A. Dean I want to assure you, we on the board have started conversations on giving. We have started highlighting the box at the back for visitors. The online giving has started to increase now.
  - There are a bunch of logistics involved in the passing of tray for offering. It requires tellers, people to count, volunteers etc. We are lacking volunteers to do this. I assure you that we have started the conversation on this and there is a possibility that we will soon make an appeal for volunteers. Also In the annual report it states that we are revising giving and communion.

Nathanael Mathi – What I understand is that the ministry team presented the budget and elder board accepted it. So, from what I can gather, there has not been an increase in salaries of the Morningstar staff is that correct? Dean – we did a 1% increase. Nathanael – There is no motion on the floor currently so I would like to raise a motion and let the members decide what they want to do. I move that the salaries of the staff of Morningstar Christian Fellowship will be adjusted with the rate of inflation (2022) of Ontario to the maximum of 7%.

#### Motion seconded by Mark Weiser.

- Rob Taylor if the salaries will be adjusted for 7% where will we adjust the budget to make up for that?
- Kevin Casey caring for pastors and the reality of the inflation is significant right now. I want to affirm that we have not adjusted the salaries of the pastors to the level of living cost increase for a while. Let's do some thing whether today or a promise to do in the future.
- Dean we have considered a lot of things and made the adjustments after that. I said earlier that we adjusted the salaries by 1% but I was just informed by the secretary that the increase is by 2.5%. Thank you for your thought's brothers.
- Maurice Monroe People of the church should have access to pastors' salary amount. This will help the people to vote on increase in salary after comparing with other salaries. Before we vote on the motion, we should look at the salaries to make a decision as a church.
- Rob Taylor Can we have fewer staff to manage inflation and manage our already tight budget? Bulk of our budget goes to the salaries.
  - Dean We have looked into these numbers (inflation and costs). We made a choice to give a discretionary bonus considering all this. Inflation affects the church as well and

the giving to church. I assure you that we will look into the budget and salaries in the future if the situation changes.

- Julius Naredo I was a little bit concerned about hiring more staff. Can we partner more with other churches to get volunteers from other churches (collaborate) to save on budget?
  - **Dean we (the elder board) support the budget presented here as is.**
- Tim Morgan I am proposing to table this motion, after discussion bring it back to another meeting and not vote on it today.
- Kevin Casey this back and forth is healthy, what we see is that Morningstar wants to bless their pastors. Thank you, Nathaniel, for bringing this to the table. If we don't move forward with this motion, we desire that the elder board consider do we have the right people on the right seat and are we compensating them correctly? It is a bigger conversation than just salaries.
  - Dean I am open to have a deeper conversation on this and come back later to this motion. Could you just give me 3 minutes to talk with the elder board and give you a response? (Elders plus Manny go to the stage and discuss.)
  - Dean In the recent past we have changed the salaries of the pastors. One for 5% and the other to 10%. We also adjusted the salary ranges for pastors in the light of inflation. However, the church giving has been a concern for us.
  - Here is the final decision Let us vote on the current motion, which is to accept the 2023 budget, we will then get back to the congregation to vote on the motion raised by Nathanael in 6 months. By then we will be in an informed position to reassess based on the giving up to that point.
    - Motion moved by Thomas Cannivady.
    - Seconded by Alf Hutchins.
    - All in favor. 7 abstain. Motion is carried on the condition we come back in 6 months to it.

Motion 4 – We are asking for a confirmation that we engage the services of the auditor North McCollin for next year.

- Motion moved by Wally Lingard.
- Seconded by Rob Taylor.
- All in favor. 2 abstain. No against.

Dean spoke closing words –

- We are a family, and a family should be forgiving and loving to each other.
- We are working on the salaries and bonuses for the pastors.
- We had reached out to the people who left the church.
- We had reached out to the pastors who left the church.
- Last meeting, we had more members with masks, but this has reversed now, and I wanted to thank everyone who came regardless. We are going to love and welcome everyone with or without masks.
- In Covid time not all things were done perfectly, and we want to apologize if our actions were inaccurate. We apologies if you were personally hurt by that. Forgive us as Christ asked us to forgive each other.

# ANNUAL GENERAL MEETING

#### Welcome – Dean Barrant

- This meeting is in response to the vision Sunday meeting help in March.
- Board of elder's introduction.
- Executive pastor and Senior pastor introduction.
- Pastor Justin to speak on Motion resolution 1, Dennis B to speak on Motion resolution 2, and Mortimer to speak on Motion resolution 3.

#### Prayer – Armand Guanlao

**Motion 1** - That MCF affirms the document on Human Sexuality and Gender compiled by the Fellowship Evangelical Baptists (FEB) which was presented in the Notice of this Special Meeting of Members of September 24, 2023, as an addendum to our Constitution as this is consistent with scripture and strongly recommended by FEB and our attorney.

**P. Justin** – As a church we are a part of a denomination called the Fellowship of the Evangelical Baptists, and in our denomination, the highest ecclesiastical authority is always the local church. No one tells Morningstar what to believe or how to act. Our church members led by our church elders are the highest ecclesiastical authority.

Now in the challenging days we live in sadly even more details have to be put into our commonalities as churches. So, FEB has adopted a resolution on human sexuality, defining it according to God's word. FEB has gone through with the effort of putting this in a document, and we have the opportunity as being a part of this fellowship, to affirm this document so we continue to be in line with other churches who have already affirmed and are a part of FEB. **Goal of the document – to affirm the biblical view of sexuality.** There are other churches that have been brought to court over sexuality related matters. This document is a helpful thing to protect us legally, it also has spiritual and practical implications.

#### Motion moved by Richard Gravesande

#### Seconded by John Carr

Questions -

Wayne Simmons - Is this about marriage as well or is it only about sexuality?

Ans. P. Justin – this document is specifically addressing human sexuality.

**Q 2.** If a person is married before and now divorced, could he lose his membership in the church?

**Ans.** P. Justin - We have never tried to speak to different convictions about this as people have different views on divorce and remarriage. Also, marriage and divorce are not part of the document or this motion.

**Peter Mascarenes** – Why call same sex union even marriage? In FEB's documents it clearly states that the term marriage is reserved for a man and woman. Same document on page 4 calls same sex union marriage. Why is that?

**Ans**. P. Justin - Legally in our culture today, same sex union is defined as marriage. It was not even thought of as marriage before historically. FEB document does a good job in stating what culture sees as

**Q 2.** The document goes on to say – If a clergy attends a same sex marriage, it is ok. On a well-known Christian website, I was reading that attendance at a wedding generally is understood to signify one's support to the union that is being established.

**Ans**. P. Justin - Just to be clear, FEB is not suggesting one way or the other if a pastor should attend a same sex marriage. The point is if whether it is acceptable for a FEB pastor if they can attend a same sex wedding as they leave that to personal conscience as there are variety of situations in life. Officiating a wedding would be a different matter completely.

Dean – My Buddhist coworkers' father died, and I went to attend the funeral in support to the coworker. I am disclosing this, if it is an act of disqualifying, I leave that to the church.

**Janet Roblin** – What is the church's position if anyone comes into membership who is transgender? They are now the opposite of what they were born with. How does the church address that from a ministry standpoint?

**Ans**. P. Justin - We always want to present the truth in love. The truth is we were created male and female. And as believers in Jesus Christ, covenant gathering in a local church, we affirm that, and will encourage others to affirm as well. As a requirement for membership, we would lovingly state the truth, regardless of what struggles they were facing, or related to some other issues, we would present the truth in love.

• Dean – we should be the people who love other people regardless. If Jesus had not loved us regardless, we would not be in the church.

**Glenda Jerome** – Question reading officiating the same sex marriage, this is an issue according to the Bible.

**Ans**. P. Justin - The document is not permitting to officiate same sex marriage, and this is a different issue. No church affiliated with FEB is allowed to officiate same sex marriage and we affirm that.

#### VOTING - All in favor. One abstains. No against. Motion carried.

**Motion 2** - That MCF makes the legally required amendments to our Constitution as instructed by the Ontario Not for Profit Corporations Act and reviewed by our attorney as per the corresponding document presented in the Notice for this Special Meeting of Members of September 24, 2023.

**Dennis B** – provides ONCA background.

- ONCA was proclaimed in force on Oct 12, 2021. Charities were given 3 years to make the changes that came as result of the ONCA requirements.
- ONCA requires the charities to become compliant with the act no later than Oct 19, 2024.
- There are a few rules to ONCA- mandatory rules, default rules and optional rules.

We are grateful to the pervious board who looked into the ONCA rules in 2021 and they made a lot of changes to the constitution already so there are only a few changes we need to make now.

We reached out to our lawyer with all our recommendations, and he came back to us with his changes and recommendations that we are presenting to you today. Document has been posted on the website for you to review.

Dean – Brother Dennis attended a legal conference and we found out that government of Ontario is making changes to laws governing corporations, with changes that affect charities also. We are both

corporation and charity. Some changes are mandatory, and some are time sensitive. So, we asked our lawyer to look into the changes due to ONCA. Our Lawyer looked at the act and our constitution and then made recommendations with regards to changes we should make.

#### Questions -

**Paul Wismer** - When was the church incorporated? And who was the legal firm that advised us on the incorporation? Did we have the elder board functional at that time? As a church member I would look to the elders rather than the lawyers for advice on matters like these.

**Ans**. Dean – We will get back to you on your questions – Who was the legal firm that advised us on the incorporation, and how long we have been incorporated for?

**Nathanael Matti** – Section 4.08 are any of the changes suggested in that mandatory? Dennis answers "No this is just to clarify." So I move that we split this motion section 4.08 to take up separately in a meeting.

**Dean** – We are here based on legal advice.

**Nathanael** – Legal advice is just some advice, two different lawyers might give two different recommendations.

**Nathanael** - Reason for requesting a separate meeting for section 4.08 are several ambiguities found in language of this section. We can go over it now if you want.

**Ans.** Dean – We the board have sought advice, we received advice and we are presenting advice to the church in the motion. We are going to present the motion and ask everyone to vote on it. To the church – We have presented the motion and we want you to make a decision on whether we go forward with the motion or not. We are going to vote on the motion to keep it as it is, and that means that we have voted on not to change it.

**Nathanael** – I have some questions then. In 4.02 it states 10% of membership. What kind of membership, is it full membership?

Ans. Dennis – This is full membership. This was one of the default rules.

**Nathanael** – It is not clear here whether it is 10% of full membership or 10% of all members. So, can we include the word "full" here?

Dean – We will come back to you Nathanael in a minute, we have a motion at hand here, can someone move the motion here?

#### Motion moved by Richard Gravesandy

#### Seconded by Karlene Barrant

Dean – We are going forward with this motion, and we are open to make change to add "full" membership instead of membership.

**Nathanael** – the correct and best way to handle this properly would be to do an amendment, so I move we amend section 4.02C to replace the word membership to full membership.

Ans. Dean – we can do that.

**Nathanael** – on section 4.08A – in that there is a sentence that says "Quorum for transaction of business where in the act requires a vote of two thirds of members presented in the meeting in order to vote on a matter called for the purpose shall be 51% of the members. Then in yellow it says, "with the exception" and continues with only 40% required. What is the rationale of inserting the words "with the exception" as this is modifying the original wording?

**Ans**. Dean- The possibility exists of multiple locations or virtual attendance where less members may be present, and this exception factors this in.

**Nathanael-** I think these sentences are meant to be three separate things. 1) Regular quorum when there is a meeting, 2) Circumstances where quorum needs to be changed, 3) The 40% is required for circumstances such as new member votes over both 9 & 11 am services.

**Ans.** Dean- The wording of this has been reviewed by P. Justin, P. Dennis and Christian lawyer, and it's not something we have come up with on our own.

Wayne Simmons - What is the difference between full membership and membership?

Ans. Dennis Bennett- Section 2.02 of the constitution references to associate members.

**Ans.** Justin Huffman – We allow underage members (under age 18) to join the church, but they aren't allowed into full membership with the right to vote until 18.

**Tyler Fischer** – Section 4.04 says no less than 10 days and no more than 50 days for a call to a meeting. And previously it was not less than 21 days. I do not agree with that, I think 21 days was sufficient notice. People sometimes take 2 weeks off, and if there is an important meeting coming up and notice is only 10 days then they can potentially miss that meeting. For this reason, I will vote this down. If we had a separate QA session, that would have been helpful, and I agree that splitting this motion to another meeting will be helpful.

Ans. Dean – There are times when something urgent comes up and we need to vote on it soon. This is just a leeway to vote and go to the congregation in just a little more than a week. This does not mean that we will give only 10 days notice always. This is just for very urgent situations. Due to this, I am accepting this flexibility.

Peter Mascarenes – first of all, here is the answer to the question asked by brother Paul – our church was incorporated on March 31, 1976, as Churchill Height Baptist church and then again on May 17, 2006, as Morningstar Christian fellowship. Piggybacking on Tyler 'comments – Constitution does have a provision of special meeting if quorum is needed. In that you do not need to give a notice, once quorum is met you can vote.

**Ans**. Dean – I am open to make an amendment to section 4.02C membership to full membership, also to break it up in three parts. We are going to review this and speak to our lawyer again. If there is any issue, we will bring it back in March AGM meeting.

Dennis – We will be voting now with the amendment that we will be changing section 4.02 to 4.02C from membership to reflect full membership.

#### VOTING - All in favor. 6 abstains. No against. Motion carried.

**Motion 3** - That MCF adopts the changes to our constitution to include Proxy votes as per the corresponding document presented in the Notice of this Special Meeting of Members of September 24, 2023.

Mortimer - We want the staff and members who are working downstairs, to also have a chance to vote at AGM and other special meetings like this one. And we have come up with a solution after a lot of discussion. This can also be extended to members who are sick and can't make it, members who have work shift etc. and we would like all our members to have equal chance to vote.

Dean – The staff and volunteers who take care of our kids downstairs, also wanted to be a part of voting and I recall, we used to have proxy voting provision in the past in our constitution. There was a change made to remove proxy voting sometime back. The reason to bring proxy voting back is to give everyone serving downstairs the opportunity to vote again.

#### **Motion moved by Dianne Simmons**

#### Seconded by Zaheer Din

Dean – by the way we generated the wordings of this motion and submitted to our attorney.

#### Questions –

**Rogelim Nessia** - How are we doing in updating our membership list. Is it up-to-date? Do we know which are active and inactive?

**Ans.** Dean – Last night I got an email from the church office with our total membership. So yes, it is updated regularly. Yes, the ministry team can give us the information of who are active and not active members.

Janet Roblin – proxy is for all members or active members?

Ans. Dean – for all qualified members.

#### VOTING - All in favor. No abstains. No against. Motion carried.

**Motion 4** - That the MCF 2023 Budget be amended to reflect a year to year increase up to 7%, consistent with Canada's inflation rate, for MCF church staff wages and salaries.

Dean - This motion is the main reason we are having this meeting. Brother Nathanael moved this motion seconded by Mark Weiser. In March we had this motion tabled and we promised to get back to you after we look into our finances. So here we are. Brother Many is going to present some initiatives.

Pastors and church staff were asked to leave the meeting for this motion.

**Manny** - I will be presenting to you some of the options taken by the board with respect to remuneration both in 2022 and in the coming year. Later I will present an update on the weekly giving and will touch on our Board Designated Funds and there will also be a slide on latest economic indicators.

#### Board Initiatives –

- Discretionary bonus (2022) that was not budgeted was paid from Board Designated Fund.
- Reviewed & increased salary ranges as some pastors were at max salary scale.
- Base salaries paid to staff effective March 1, 2023.
- First drafts of 2023 Budget was lowered without reducing salaries. Even when the revenue was lower, we only made cuts to capital expenditures.
- Discretionary bonus is now included in the 2023 Budget and will be paid in Dec of this year.

Combined impact of salary increase & discretionary bonus will be 4.45%

This year up to last Sunday, the average weekly giving will be \$22, 066 slightly lower than last year's \$22, 192. Therefore, based on the trend in giving, revenue target may not be reached.

Board Designated Funds – We started the year with a balance of \$165,908 last year, now we are down to \$115, 908 after taking into account all the expenditures (Tapscott payment, carpet replacement etc.)

Morningstar just got an email from Feb that they are increasing the group insurance policy by 8.5% effective Aug 2023. Impact of the rising cost is for everyone, to church, staff and members.

Canada inflation rate was 6.8% last Oct. It is now down to 4%. Just to recap the combined salary increase and bonus provided to the staff will be 4.45%.

Dean – so when the motion was moved in March stating inflation was 7%, inflation actually was 5.7%. We with all our heart want as much as possible to support our staff here and that is the reason with giving being low, we gave bonus from BDF and budgeted bonus for this year. Please keep in mind that we are a charity and not a for-profit corporation.

So here we are now in Sept 2023, and from what we have seen since March that the giving has been at 2022 level and has not increased and has been lower in 2023.

The duties that you have assigned to us is to secure spiritual growth of the church, but we also have to be good stewards of its resources. We as the board of elders cannot support this motion at this time. We will look at the giving for the rest of the year and see where we can budget for salary increase.

#### Questions –

**Benji Francisco** – I believe members of Morningstar are faithful givers and members are also employed (mostly). Nobody ever receives a salary increase of 7%. The most we have ever received is 4%. People like me don't even receive 2% increase. So, 7% is too much and I understand the difficulty faced by the elder board making this decision. We must be good stewards of our church money.

**Peter Mascarenes** – I agree with the board disagreeing with the motion. I have a two-part question – A. what is the administrative percentage of Morningstar expenses? B. We are hiring a new communications administrator. I am wondering if board has considered reducing the staff and give more to the current staff rather than increasing our staff count?

**Ans**. Dean – There was an advertisement for the Comm specialist for office and we as board asked about it also. That is a replacement of current staff member (Janice Garraway) who decided to leave.

Ans. Manny – the percentage of administrative staff for Morningstar is 58% currently.

**Nathanael Mathi** – the 4.45% bonus and increase in salary is not distributed evenly among all staff equally. The wording there in the motion is to provide up to 7% and not to provide 7%. Just like there is increased pressure on the budget, the same cost is higher for people as well.

• This motion was moved then and was moved based on the question I asked, "what was the salary increase given to the staff and based on my understanding, the answer was 1%".

**Ans**. Dean – Nathanael your understanding is incorrect, we said 1% to some and 10% to other. Total increase was more than 1%. Nathanael you and I had a conversation last week Sunday because I wanted to ensure the wording of the motion was consistent with what you said. Until last week I thought you asked for 7% increase in salary consistent with the inflation rate at that time. After our conversation I also added "up to" 7%. We considered everything and wrestled with this, and now we have come back

with an answer. Also, we have some other considerations to bless our pastors with, but the board has not authorised me to disclose it here at this meeting.

Nathanael – it is good to know that there are other considerations and that is what was expected. I was not hearing these and that is why I was asking these questions.

**VOTING** - We as a board cannot support up to 7% increase in salary at this time. Here is the motion in front of you on which congregation needs to vote.

Motion was voted upon and did not carry. Few in favor, mostly against. Result – motion dissolved.

**Dean** – closing words.

Closing prayer – Wisdom Marks

Motion 5 – Special Meeting adjourned.




10 Year Trend (2014 - 2023)









### **INDEPENDENT AUDITOR'S REPORT**

To the Directors of Morningstar Christian Fellowship SCARBOROUGH Ontario

#### Qualified Opinion

We have audited the accompanying financial statements of Morningstar Christian Fellowship which comprise the statement of financial position as at December 31, 2023 and the statement of operations - unrestricted fund, statement of changes in fund balances and statement of cash flows for the year then ended and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, except for the effects of the matter described in the Basis for Qualified Opinion paragraph, the accompanying financial statements present fairly, in all material respects, the financial position of the entity as at December 31, 2023 and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

#### Basis for Qualified Opinion

In common with many not-for-profit organizations, the entity derives revenue from contributions, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of the entity. Therefore, we were not able to determine whether any adjustments might be necessary to contributions revenue, deficiency of revenues over expenses, and cash flows from operations for the years ended December 31, 2023 and 2022, current assets as at December 31, 2023 and 2022, and fund balances as at January 1 and December 31 for both the 2023 and 2022 years.

Our audit opinion on the financial statements for the year ended December 31, 2022 was modified accordingly because of the possible effects of this limitation in scope.

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the entity in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

#### Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the entity or to cease operations, or has no realistic alternative but to do so.

#### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2023

#### PURPOSE OF THE ORGANIZATION

Morningstar Christian Fellowship (the "Church") is an assembly of believers in Jesus Christ which exists as a particular expression of the universal body of Christ with the purpose of offering acceptable worship to God, instructing and edifying the people of God, and reaching out to unbelievers by means of evangelism and social action in the community of Scarborough. Morningstar Christian Fellowship is incorporated under the Ontario Corporations Act as a not-for-profit organization and is a registered charity under the Income Tax Act.

#### 1. SIGNIFICANT ACCOUNTING POLICIES

These financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations and include the following significant accounting policies:

#### a) Fund Accounting

Resources are classified into funds according to their activities or objectives specified as follows:

The Unrestricted Fund reports net assets, donations and expenses related to the operations and administration of the Church.

**Internally Restricted Funds** represent funds set aside for future expenditures. Board Designated Funds may be utilized at the Board's discretion for expenditures not provided for in the annual operating budget. Funds for the School of Music, Dramatic Productions, and Sports Ministries have been established to cover future shortfalls in their own respective areas.

**Externally Restricted Funds** represent funds whereby the original contributions have been restricted by donors. The externally restricted funds are as follows:

The Benevolent Fund represents restricted contributions designated to provide aid to those in need.

The Short Term Mission Fund represents restricted contributions designated to be used in certain short term mission trips.

The Refugee Assistance Fund represents restricted contributions designated to be used for refugee assistance.

The Special Offerings Fund represents restricted contributions designated for specific short-term needs as approved by the board.

#### 1. SIGNIFICANT ACCOUNTING POLICIES - Continued

#### b) Revenue Recognition

The Church follows the restricted fund method whereby externally restricted contributions are recognized in the fund corresponding to the purpose for which they were contributed. Restricted contributions for which there is no fund are recorded in accordance with the deferral method. Unrestricted contributions are recognized as revenues in the Unrestricted Fund.

Investment income, including dividends and interest earned on any restricted investments held in support of a restricted fund is recognized as revenue in the appropriate fund when earned. Investment income earned on unrestricted investments is recognized as revenue in the unrestricted fund.

Revenue from facilities rental and other miscellaneous services is recognized when services are provided and collection is reasonably assured.

Government assistance is recognized when received and any conditions as to its use have been met.

#### c) Use of Estimates

The preparation of financial statements in accordance with Canadian accounting standards for notfor-profit organizations requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reported period. Actual results could differ from the estimates used.

Significant estimates include the estimated useful life of capital assets.

#### d) Cash and Cash Equivalents

Cash and cash equivalents include cash and term deposits with a maturity period of three months or less from the date of acquisition.

#### e) Investments

#### **Marketable Securities**

Marketable securities, which are investments traded in an active market, are recorded at fair value.

#### Investments in Non-Publicly Traded Shares

Investments in non-publicly traded shares are recorded at cost. A provision for write-down is made when the decline in value of a particular investment is considered other than temporary.

#### 1. SIGNIFICANT ACCOUNTING POLICIES - Continued

#### f) Capital Assets

Capital assets are recorded at cost. Amortization is being provided over the estimated useful life of the assets using the following annual rates and methods:

Building	3% declining balance
Furniture and equipment	20% declining balance

#### g) Impairment of Capital Assets

When a tangible capital asset no longer contributes to an organization's ability to provide goods and services, or the value of future economic benefits or service potential associated with the tangible capital asset is less than its net carrying amount, the net carrying amount of the tangible capital asset is written down to the asset's fair value or replacement cost.

#### h) Contributed Services

Volunteers contribute significant hours per year to assist the Church in carrying out its activities. Because of the difficulty of determining their fair value, contributed services are not recognized in the financial statements.

#### i) Financial Instruments

#### Initial Measurement

The Church initially measures its financial assets and financial liabilities originated or exchanged in arm's length transactions at fair value.

#### Subsequent Measurement

The Church subsequently measures all its financial assets and liabilities at amortized cost, except for investments in equity instruments that are quoted in an active market, which are measured at fair value. Changes in fair value are recognized in the deficiency of revenues over expenses in the period incurred.

Financial assets subsequently measured at amortized cost include cash and cash equivalents, receivables, and DUCA investments. Financial liabilities measured at amortized cost include accounts payable and accrued liabilities.

Other than investments in Canadian equities, the Church has no financial assets measured at fair value and has not elected to carry any financial asset or liability at fair value.

#### 7. FINANCIAL INSTRUMENTS

#### **Risks and Concentrations**

The Church is exposed to various risks through its financial instruments. The following analysis provides a summary of the Church's exposure to and concentrations of risk at December 31, 2023:

#### a) Credit Risk

Credit risk is the risk that one party to a financial instrument will cause financial loss for the other party by failing to discharge an obligation. The Church's main credit risks relates to its receivables. There is no allowance for doubtful accounts in the current or prior year. There has been no change in the assessment of credit risk from the prior year.

#### b) Liquidity Risk

Liquidity risk is the risk that the Church will encounter difficulty in meeting obligations associated with financial liabilities. The Church is exposed to this risk mainly with respect to its accounts payable and accrued liabilities. The Church manages this risk by managing its working capital and by generating sufficient cash flow from operations. There has been no change in the assessment of liquidity risk from the prior year.

#### c) Market Risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: currency risk, interest rate risk, and price risk. The Church is mainly exposed to price risk as follows:

#### i) Price Risk

Price risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices (other than those arising from interest rate risk or currency risk), whether those changes are caused by factors specific to the individual instrument or its issuer, or factors affecting all similar financial instruments traded in the market. The Church is exposed to price risk through its investments in quoted shares. The exposure to this risk fluctuates as the Church's investments change from year to year.

#### 8. GOVERNMENT ASSISTANCE

The Church has received \$81,107 (2022 - \$Nil) Canada Summer Job government assistance for their summer internship program. The purpose of the assistance is to reimburse the payroll expense to the youth internship program.
